South Worcestershire Development Plan Review Publication Consultation (Regulation 19)

Public consultation on the South Worcestershire Development Plan Review Publication Consultation (Regulation 19) was approved by each of the South Worcestershire Councils in October 2022. This draft version of the Local Plan is known as the Publication Plan.

The consultation begins on 1 November 2022 and closes at 23:59 on 13 December 2022.

This final draft of the Plan has been informed by earlier consultation responses received during the Issues and Options consultation in November 2018 and the Preferred Options consultation in November 2019 and updated technical evidence.

This is the last public consultation on the Plan prior to it being submitted to the Planning Inspectorate for independent Examination

The Regulation 19 consultation is specifically seeking views on the following:

- Legal Compliance does the plan meet the legal requirements made under relevant legislation?
- Soundness has the plan been positively prepared, justified, effective, and consistent with national policy?

This statement has been prepared by Malvern Hills District Council, Worcester City Council and Wychavon District Council (the South Worcestershire Councils) pursuant to the Town and Country Planning (Local Planning) (England) Regulations 2012 (Regulations 19, 20 and 35), as amended.

Title of the document: South Worcestershire Development Plan Review Publication Consultation (Regulation 19) November 2022.

Subject matter:

The Plan includes the South Worcestershire Council's proposed strategic and development management policies, as well as specific sites proposed for allocation for residential, residential-led mixed-use and employment land uses. The Plan sets out how the South Worcestershire Councils intend to deliver sustainable development, by positively shaping growth to unlock a range of benefits whilst mitigating against potential negative impacts.

A Policies Map has been published as part of this consultation, which indicates geographically the application of the policies in the SWDP Review Publication Consultation (Regulation 19) Plan.

Period for submission of representations: Representations are invited on the SWDP Review Publication Consultation (Regulation 19) Plan from 1 November to 13 December 2022. Representations must be received by 23:59 on Tuesday 13 December 2022. Representations received after this time will not be duly made and may not be accepted.

Things to consider when making a representation:

When making representations on the Plan, the following questions should be considered:

<u>Is the plan legally compliant?</u> Does the Plan comply with the relevant legislation and regulations in the way it has been prepared, and in its content?

<u>Is the plan 'sound'</u>? Has the Plan been 'positively prepared'? Is it robustly justified and evidence-led? Is it effective and deliverable? It is consistent with national policy?

How to submit a representation:

Representations should be made on a representation form where possible. Please complete these forms (which comprise one Part A form for personal details, plus a Part B form for each representation that is being made), ensuring all required answers are provided. Please include a completed Part A form and as many completed Part B forms as relevant.

We strongly recommend that all representations are made using the standard representation form provided, whether you complete it online, download and complete it on a computer and submit by email or post, or print it off to provide a handwritten response and post it to us. This helps to ensure that all comments received are relevant and that the correct information is collected to allow representations to be considered fully by the Planning Inspector appointed to examine the Plan.
